A Master Concept Plan has been developed for the 7 Sibley Street Design Team by Mark Floate.

The idea behind the Master Concept Plan is to enable community discussion and decision-making in relation to the site, as it is not the final plan for 7 Sibley Street.

The design team considered input from the community at the Forum in 2012 and the Design-In in 2013, as well as council feedback. As much as possible was incorporated.

From these workshops and meetings, three distinct types of spaces keep recurring as ongoing themes, and these have become the basis for the areas provided in the plan.

The three types of spaces are:

- Learning Spaces – “clean space” – reception, information exchange, display / exhibition, library, seminar, meeting / discussion, link-up centre.
- Production Spaces – “dirty space” – workshops, shared tool space, community kitchen, food storage.
- Landscape Spaces – “garden space” – green open space, active exercise, quiet relaxation, hard-stand areas, kitchen gardens, food security.

Challenges include disability access – equitable, barrier-free access across the whole site, including the old skate park site

The Lismore City Council has indicated there will be a need to allocate sufficient space for parking. Vehicular access across the site is another issue, with the need to provide parking as well as delivery vehicle / emergency access.

The council has also indicated that the development of 7 Sibley Street should link 7 Sibley St with the new Sk8 Park and Peace Park.

There is a need to maximise airflow and minimise dampness, so building into the ground or directly onto the ground is not preferred at this stage.

Other considerations



include optimising the solar passive potential of the site, optimising replicability and affordability of design; a need to link the whole site together for aesthetic and functional reasons; impact on the surrounding area.

The idea of treating the upper and lower levels as two separate areas with separate access meaning disabled access between the two levels is not necessary.

The buildings across the site should be linked by an “arbor” – a sort of long deck/verandah which may feature art spaces. Some areas are to be temporary constructions which can be reconstructed

as part of ongoing skills development.

Materials have not yet been decided, with a preference for hemp and timber. A tool will be developed to rate materials according to their sustainability, and this will be used to assist the decision making.

The estimated cost of the total development is around \$500,000. It is likely that a staged approach will be taken.

The ultimate goal is for the site to be as multifunctional as possible and retain green/open space in the village.

Other plans include:

- Providing outdoor exercise

and fitness opportunities;

- Generating kinetic energy to be used to power innovative elements of a life-scale game which will be part of a larger game which will progress along the Nimbin Walking Track;
- Generating kinetic energy to demonstrate various aspects of renewable energy generation, use and technologies in an entertaining and engaging way.

In this way, the site will link the existing skate park and peace park recreational area, with the Sustainable Living Hub, which has a strong renewable energy focus.

NNIC gets into Green Globe finals

The Nimbin Neighbourhood and Information Centre (NNIC) is a finalist in the NSW Government's Green Globe Awards recognising their outstanding commitment to sustainability. Nationals Member for Lismore, Thomas George said, "The NNIC is an outstanding grassroots organisation that

has revitalised the community and strengthened the local economy through their environmental initiatives."

The Centre was short-listed for the Community Sustainability Award that celebrates leadership in integrating sustainable principles and practices into everyday life.

"The collaborative approach taken by the Centre when implementing sustainability projects, including the Community Solar Farm, means the whole Nimbin community should be congratulated on this achievement," Mr George said. Environment Minister Robyn Parker said all of this year's 37 finalists showcase the economic and social benefits of sustainability.

"This year's high calibre finalists demonstrate that environmental sustainability has become key to successful project and service delivery," Ms Parker said.

Radio activity in Nimbin 'safe'

In May this year, NBN Co held a community information session to discuss its plans to deliver a fixed wireless high-speed broadband service to Nimbin.

During this session the community raised concerns about the effects of radiofrequency signals, or radiofrequency electromagnetic energy, on public health.

Following this session, Ericsson, working as NBN Co's construction partner, commissioned a survey of the existing radio frequency signals in Nimbin to give visibility of the current radiofrequency energy already in the community.

This survey was undertaken by an accredited and independent radio frequency assessor on 18th July 2013, at locations nominated by members of the Nimbin community. Those community representatives were also in attendance and observed the testing as it was being undertaken.

At outside locations, the cumulative radiofrequency signal strengths ranged from 147 times below the safety limit

(adjacent the community FM radio transmitter) to 24,390 times below the safety limit (in front of Nimbin Organics).

Inside Nimbin Organics, the cumulative radiofrequency signal strength was 71,428 times below the safety limit – almost three times lower than outside.

At the public school, the combined radio frequency signal strength was 20,408 times below the safety limit.

This means that the FM community radio transmitter on Cullen Street produced the strongest radiofrequency signal detected at any location. It accounted for 94% of the total radiofrequency energy present in the Nimbin Neighbourhood Centre car park.

However, only 250m away, out the front of Nimbin Organics, the community FM radio signal strength was 84 times lower than the car park.

The report concluded that across Nimbin, mobile network signals were so low as to be barely detectable by the testing equipment – they were negligible compared to the FM radio and UHF TV signals, which themselves were very low compared to the safety limit.

Mobile network signals were more easily detected outside Rainbow Power, where there is a clear line-of-sight to the facilities on Mount Nardi.

This environmental data at Nimbin is consistent with advice from the following World Health Organisation (WHO):

"The strength of RF fields is greatest at its source, and diminishes quickly with distance..."

"Recent surveys have indicated that RF exposures from base stations and wireless technologies in publicly accessible areas (including schools and hospitals) are normally thousands of times below international standards." (Ref: WHO Fact Sheet: Electromagnetic Fields and Public Health: Base Stations and Wireless Technologies)

NBN Co will be holding a second information session in Nimbin on 2nd September, 3-6pm at Nimbin Town Hall.

The full EME survey report will be available at the session and Michael Bangay, the independent radio frequency assessor who undertook the survey, will also be there to answer questions.

Infernal tower battle goes on

The people of Lillian Rock and Barkers Vale in the Kyogle Shire are fighting against NBN Co fixed wireless tower proposals.

Residents have launched the OREAD Project (pronounced Oh-Ree-Ad. Oreades were the spirits who protected the mountains in the classical world). OREAD is intent on protecting humans and wildlife from the effects of radiation from NBN Co towers.

A 50-metre lattice tower has been proposed for Lillian Rock Road, which has stirred locals into action.

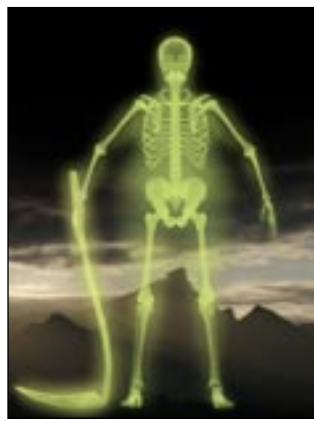
At least seven residences at the western end of Lillian Rock Road have refused offers by NBN Co to

host towers on their land, despite financial incentives understood to amount to \$100,000 over a 20-year period.

Concern that potential tower sites could emerge anywhere inspired OREAD to embark on a microwave-awareness information program, with the intent of halting all towers in residential areas.

While NBN Co has had community consultation in Nimbin, there has been no communication with Kyogle Shire communities.

The tower placement is geared to serving the Lismore side of the valley. NBN Co describes the area as "sparsely populated", when it is in fact



the most densely populated area in the Kyogle Shire, outside the CBD.

NBN Co informed residents within 200 metres of the proposed tower, while in Victoria, they informed residents up to 1km away.

OREAD has been collating information on the health impacts of this form of radiation, how these emissions affect cellular activity and the formation of blood cells in the bone marrow as well as a other effects on the hormonal system.

Residents from Homeleigh through Barkers Vale have been undertaking a full blood count through health professionals to form a baseline to refer to should towers be erected near them. Any deterioration in the blood through a follow-up test after residents have been exposed to radiation from a tower could be grounds for litigation.

John Ordish Christian Democrats

Kevin Hogan
The Nationals

Nationals misleading

Every householder in NSW recently received a misleading leaflet from the National Party stating that the Federal carbon tax and green energy schemes add about \$330 a year to a typical household electricity bill. This equates to \$6.35 per week.

According to the Department of Resources, Energy and Tourism, householders should expect an average increase of \$3.30 per week as result of the carbon tax. To offset this and other cost of living increases associated with the carbon tax, householders are receiving on average \$10.10 per week. No one is currently out of pocket as a result of the carbon tax, in fact typical income earners are better off as the carbon-tax related cost increases are less than \$10.10 per week.

The remaining \$3.05 per week is attributable to the installation of energy saving devices. This is an investment and a long-term cost saving measure to consumers, not irrecoverable expenditure as this leaflet suggests.

Good times at other's expense?

Many local Greens supporters can't see the point in making unfounded accusations about a political organisation sprouted in Nimbin with the sole purpose of repealing prohibition.

The HEMP Party exists because of the Green's failure to recognise the importance of cannabis issues.

What the Greens do and say off-the-record is not reflected in their policy on Cannabis. The Greens have bundled 'marijuana' with other illegal substances and make no reference to the suitability of hemp for green technology and permanent agriculture, nor do Green policies mention the nutritional benefits of hemp seed foods for humans or as stock-feed.

The promise of a 'Drug Summit' may be enough to save some votes, but the Greens need to lift their game to retain the faithful. The Greens' idea of a high-speed rail link for the capital cities is a prime example of how out-of-touch the Greens are with supporters from the rural areas, where their policies for sustainability would ultimately be put into practice. Spending money on a fast train set that cuts through the landscape with steel and concrete doesn't sound very Green, or necessary.

Liberal Party preferences gave the seat of Melbourne to the Greens, and Greens preferences elected a Shooter & Fisher to Parliament in

Western Australia. Such eventualities are virtually impossible to predict.

The NSW Greens preferences flow to many other parties before HEMP receive any. NSW Labor Senate preferences go to Greens, Senator Online, Shooters, WikiLeaks, Katter, HEMP, Liberal Democrats etc. In NSW the HEMP Party preferences eventually go to Greens ahead of Labor in a 2:1 split and HEMP preferences are 50/50 over the 6 States contested.

A vote for the HEMP Party is a protest vote on prohibition. Cannabis prohibition is a bi-partisan issue. Prohibition will most likely be repealed by a Labor Government with the support of the Greens and a few small parties who can accept the fact that cannabis prohibition has failed to consider your health, failed to prevent illegal supply and failed as a 'drug' policy.

Preference facts

The *Nimbin GoodTimes* is of course free to editorialise on their front page, but some attempt should be made to get the facts right before publishing slurs on the HEMP Party.

We did swap preferences with the Liberals for Forests in 2004, but far from being a 'centre-right' party they were in fact dripping wet ex-liberals who had broken away from the WA Liberals in protest against their clear fell logging policies in the Kauri forests of the south west. Being very small-L liberals, their drugs policies were better than the Greens. When they were excluded from the 2004 Senate race, their own preferences, along with HEMP's, flowed to the Greens. The fact that John Kaye did not subsequently get elected was because his primary vote was too low and had nothing to do with anyone's preferences.

The Greens Upper House Bill in 2003 was not to decriminalise cannabis throughout NSW, but was a poorly drafted plan to merely trial just two Amsterdam-type coffee shops – one in Sydney and one in Nimbin. The one in Sydney would have had to have been bigger than the Penrith Leagues Club and the one in Nimbin would have attracted so many thousands of Queenslanders every day that the locals would soon have been begging the police to set up roadblocks. It was such a dumb idea that if HEMP had any MLCs, we would have torpedoed it. As it was, no-one voted for it. The Greens having the

most cannabis friendly drugs policies? Well, with friends like that who needs enemies? The current Greens policy supports the continuation of prohibition as it is practised today.

I quote from their Drugs, Substance Abuse, Addiction policy document:
ILLICIT DRUGS

8. *The Australian Greens do not support the legalisation of currently illegal drugs.*
14. *Maintenance of criminal penalties for drug dealers, and introduction of a system of civil sanctions for personal use of illicit drugs.*

That is prohibition. That still puts Tony Bower behind bars. That still has the cops standing over users issuing cautions and then fines. That is not a progressive policy. That is a conservative's defence of the status quo.

The only correct facts in your story were in the quotes from Jim Moylan. Direct and deliberate Green preferences did elect a Shooters and Fishers (SFP) candidate, instead of a Labor candidate to the Western Australian Upper House this year. HEMP preferences cannot flow to the SFP in any state in next month's election unless a Green has already been elected.

The best place to see all of the Senate preference flows is not on the AEC's site but on the ABC's 'Anthony Green's Election Guide'.

Please try making a few phone calls to see if you have been fed the correct story in future.
