# Kyogle Hospital then and now

In previous columns, I have told the story of the establishment of a hospital in Kyogle, concluding with the opening of the Kyogle Public Hospital in 1925. This month I'll write about some of the history from that date until the present day.

Resources used are Health Services in Kyogle 1903 – 2005 (written by Helen Flower, typed and edited by Betty Fitzgerald, available in Kyogle Library) and an interview with Tom Fitzgerald OAM, Honorary Hospital Board Treasurer in the 1980's and Chairman of the Kyogle Health Services Planning & Steering Committee from 1995 to 2005.

Two very capable, long-term nurse Matrons helped to establish our hospital's reputation. Matron McKid, the first Matron of Kyogle Memorial Hospital, spent 28 years in that job from 1925 to 1953. The McKid Medical Centre was named in her honour. Her constant companion, a fox terrier known as Sweetie, is buried beside a pine tree in the hospital grounds.

The other well-known Kyogle Nursing Sister is Matron Bridie Gregory who became Sister in Charge of the Maternity Hospital in 1950 and progressed to Matron from 1968 to 1987. The Gregory Family Birth Centre and the Gregory Obstetric Unit were named in her honour. Today, the Gregory Building is on the right as you enter the hospital grounds. Matrons McKid and Gregory were awarded the OBE and OAM respectively for their many years of loyalty and work at our local hospital.

Many doctors carried out surgical procedures and obstetrics at our local hospital when such procedures were often only available in capital cities. There are 27 doctors listed as having practised in Kyogle from 1903 to 2004. One of the longest serving was Dr. Brian Perry who came to Kyogle in 1976 and retired only a few years ago.

We now have the McKid Medical Centre on the left side as you enter the hospital grounds, with five General Practitioners. Patients are now referred to specialists in Lismore, Gold Coast and Brisbane and are transferred to other bigger hospitals by ambulance or helicopter.

The original hospital that was built in 1925 had very little work done over the years and from 1970's the building was run down and difficult for staff to work in.

In 1995, as a result of new Commonwealth & State policies for small country Hospitals, the Kyogle community appointed a KHS Planning & Steering Committee with Tom Fitzgerald as its Chairman. The committee's responsibility was to determine a path into the future for the hospital.

It took ten long years of hard work and meetings and negotiations by Tom and his committee with politicians at Federal, State and Local Government levels for the original Kyogle hospital to be closed and demolished. A completely new building was designed, funded, built and opened in 2005 as our present Kyogle Memorial Multi-Purpose Service.

Kyogle, Nimbin and Urbenville are the three MPS in the Northern Rivers administered by the Northern NSW Local Health District (NNSW LHD). An MPS comprises a Rural Hospital, Emergency Services, Aged Care (Nursing Home) and Community Health in one building.

In my and many people's minds, Tom Fitzgerald OAM has been a hero in the Kyogle Hospital story and thanks to his earlier work in the 1980's, we still have the Whiddon Group Hostel behind the hospital.

At the recent NSW State Labor Conference there was unanimous support for a motion to have the North Coast declared CSG-free. An urgency motion was moved at the Conference by Janelle Saffin and myself. (see full motion below). Other speakers in support of the motion were Tweed Labor candidate Ron Goodman and Lismore Labor candidate Isaac Smith

At the NSW State election in March 2015 voters will face a very clear choice between the Labor party who want to stop CSG mining on the North Coast and the National Party who want to expand CSG mining.

The fact is a vote for Labor will be a vote to protect the North Coast from the CSG industry, while a vote for the pro-gas Nationals will be a vote to expand CSG mining.

The resolution passed unanimously by the NSW Labor Conference supports a declaration that the State Parliamentary seats of Lismore, Ballina, Clarence and Tweed be 'CSG Free'.

#### **E Zone Review**

In September 2012, the then NSW Minister for Planning announced a review of the way environmental zones were applied to land in five FNC Councils' Local Environmental Plans (LEP). The bulk of the Lismore LEP was approved so for two years Lismore has been operating with LEP 2012 for all but a small amount of land excised and development on that land still regulated under LEP

The Planning Department engaged an independent consultant and released an Interim Report in early June giving five weeks for Councils to respond. Our Council met with Planning Department staff and the independent consultant and staff prepared a submission, circulated it to Councillors for input and lodged it at the end of June.

# From the mayor's desk

At our July meeting, Council formally considered and endorsed that response. Among Council concerns with the Interim Report are consistency of terminology and application, the costs of further work, including mapping and the permissibility of extensive agriculture in E 2 zones.

#### **Community Donations**

As readers will know, Council recommended some changes to the annual community donations available under section 356 of the Local Government Act. While more significant changes are recommended for 2015 -16 and beyond, the changes for this new financial year were placed on exhibition and staff met with the groups affected most.

In a nutshell, the changes include a 20% reduction in the annual automatic grants to 11 recipients and a doubling of the grant to 29 rural halls to \$2000. Other changes related to updates to relevant policies. Most organisations welcomed or accepted the changes and only three submissions of objection were received from the Lismore Musical Festival Society (Eisteddfod), NC National A&I Society (Showgrounds) and the NC Institute of Sport.

#### 2014-15 s356 Donations

Council also advertised for the 2014/15 miscellaneous s356 donations and received 42 eligible applications for a \$2200 maximum grant from the \$27,300 funding pool. Councillors ranked their preferred top 20 applications and staff collated the results to report back to Council at the August 13 meeting. As some of the applications are for smaller amounts, approximately 15 projects are expected to be successful.

#### **NBN** tower

Council considered an application to erect a 40m NBN Co fixed wireless broadband monopole tower with antennae on the southern end of the Nimbin Showgrounds. There are some people vehemently opposed to towers and some who are desperate for better broadband coverage. Some may want fibre to the home or node instead but the reality is that wireless technology will be rolled out in non-urban

I can assure readers that Councillors take our decisions seriously with site visits, reading of submissions and careful consideration of the issues. Each of us votes according to what we see as being in the best interests of the community, now and into the

 $\mathbf{I}$ t's been an extraordinary winter. I don't remember one like it with such cold dry conditions. One of my friends reported 10 consecutive days of frost at his property.

One of my main focuses at Council recently has been to work with other Councillors, staff and interested residents to develop a land management policy that effectively protects our endangered environmental communities while not destroying our relationship with

the farming community by overwhelming that important sector with regulation. I'm hopeful that Council will eventually develop a mix of incentives and minimal backup regulation that will prove effective. Any ideas on this complex issue are always welcome.

Council continues its energy and greenhouse gas reduction action by installing its biggest solar hot water system yet, with hundreds of solar evacuated tubes now visible on the roof of the Lismore Memorial Baths.

The solar evacuated tube system is the final component in stage one of the Community Energy Efficiency Program, funded by the federal government and Council's Cities for Climate Protection Fund.

Altogether the energy efficient measures represent a collective saving of \$124,000 per year, which equates to 531,273 kilowatt hours. More importantly, it will reduce Council's CO2 emissions annually by 561

On the Gasfield Free Communities front, the Minister is continuing Metgasco's licence suspension and Metgasco will be returning to the Supreme Court in October to fight the Minister's decision.

Given the huge drain on police resources in November with the G20 in Brisbane, the demands of Christmas and the looming state election in March, it is hard to see how there will be any police resources available to try and get Metgasco into the Bentley site before

April/May 2015. What a shame!

Great to see the Labor Party listening to the people of the North Coast by passing a motion at its State Conference to halt unconventional gas drilling in the Northern

It's a shame that the ALP ever allowed it to happen in the first place. But with ministers like Obedd and Macdonald what can you expect? To be fair, Chris Hartcher, the coalition's ex-minister for mining, is also under investigation by ICAC. There must be something about that ministry.

At Lismore's last Council meeting, Council accepted my motion for the annual Local Government Conference: that the Conference ask the NSW State Government

- Declare 'no-go zones' for mining and gas in our drinking water catchments and to protect our rivers, streams, wetlands and groundwater.
- Declare 'no-go zones' for mining and gas on our productive farmland and in areas where it will have a negative impact on local
- Declare 'no-go zones' for mining and gas development in our iconic wild places, conservation areas, State forests and travelling stock routes.
- · Set strong limits on air, noise, water, and carbon pollution from coal and gas developments.

- · Give landowners and local councils the right to refuse access to mining companies and to restoring the legal right for the community to appeal mining approvals in the courts.
- · Put in place an independent, transparent and rigorous assessment of mining and gas projects and strengthen monitoring of existing operations and penalties for

The motion was voted against by Crs Meinke and Scheibel, both of whom stood on a no-gas platform at the last Council election!

Trish (my wife) and I have just returned from a 2,000km trip around Western NSW. I gave three talks about Bentley and the Gasfield Free initiative as well as doing training. We had a great reception and it isvery clear that the people around the Pilliga and Maules Creek are in the fight for their livelihood and inevitably 'their' environment.

One farmer west of Burren Junction, who farms 8,000 acres and has large overheads and debts, said that even Santos (the miner) says their operations would lower his water bores by 14 metres. He said this would completely destroy his family's farming enterprise.

This is some of Australia's most productive farmland – hard to believe that a few brief years of fossil fuel energy exported overseas could get priority over food production for
