Funding for Elders' cultural space

Nimbin Health & Welfare Association Inc (NH&W) have been successful in their bid for Federal funds to develop a culturally appropriate space for Aboriginal and Torres Strait Islander Elders in Nimbin.

NH&W have been awarded \$45,000 from the NSW Department of Health, Dementia and Aged Care Services (DACs) Fund for capital works for activities focusing on Aboriginal and Torres Strait Islander people.

The grant application was significantly strengthened



by a contribution from the Nimbin Community Centre

(NCCI) of \$4,635 with an additional \$2,400 to be sourced from community fundraising to cover the total construction cost of \$52,000.

An attractive veranda extension is planned, with bi-fold doors to maximise the flexibility of the space, providing a welcome addition to Bottlebrush Studio, home of Nimbin Aged Care & Respite Services (NACRS) and contributing to the Nimbin Community Centre.

A working party including local Aboriginal Elders, NACRS Aboriginal support workers, NACRS and NCCI co-ordinators and

the veranda project manager will workshop the design and oversee the planning application, build, furnishing and decoration of the space. We aim to complete the project by the end of 2018.

Donations towards the \$2,400 target for community contributions are very welcome from businesses and individuals.

Robbery on the high seas

The plunder of Timor's maritime resources

Like myself, Shirley Shackleton, widow of murdered Australian journalist Greg Shackleton (now in her eighties), made a snap decision to make an overnight trip to Canberra for the Timor Sea Justice Alliance deputation to Senators in June.

Still jet-lagged from a return trip from Indonesia that morning, when she learned that former Attorney General of the ACT Legislative Assembly, Bernard Colleary was speaking, she called a cinematographer making a documentary about her to get ready for the 3pm flight to Canberra from Melbourne. (The cinematographer, Luigi was involved in the making of *Balibo*, and later, the prizewinning movie about the Indonesian invasion of East Timor, *Beatriz*.)

Bernard Colleary is the lawyer who took Timor's rights to its sea boundaries to a compulsory United Nations Conciliation Commission to force Australia to recognise a decision handed down by the UN over a decade ago. Australia was to abide by international maritime law (that sea borders be determined by a half-way mark between the nation states).

Successive Australian governments have refused to recognise this decision, claiming that a 'treaty' was signed with Indonesia before Timor was recognised as independent. No longer part of Indonesia (though East Timor never was), the sea

boundaries of the 'treaty' were no longer relevant, and therefore the 'treaty' would be invalidated. Initially the Australian government refused to acknowledge the authority of the Commission.

Bernard Colleary had his offices raided by ASIS (Australia's international security organisation) and his computers and documents seized while he was overseas. He was isolated overseas for ten months because there was a threat by the Coalition government of the time to prosecute him for taking the case to the UN. On the lawn in front of Parliament house he described the raid:

"My clerk was held on the floor, her mobile phone seized, held incommunicado and treated like a criminal. Interestingly they went into the ceilings ... in the bedrooms ... to take out whatever they had (installed) up there and took thirty years of files, including my communications with Xanana Gusmao (former president of Timor Leste, and resistance leader during the years of Indonesian occupation)... all of the leadership, going back to the

eighties."

He went on to describe the treatment of the senior ASIS officer who leaked the fact that ASIS had bugged the conference room in Timor Leste where the 'negotiations' were being discussed: "Witness K ... could tell us a lot, and that is the reason why he is being denied a passport by Foreign Minister Julie Bishop. ASIS has said that it would be incorrect to allow witness K to give evidence; that it would damage national security."

Colleary added that ASIO (responsible for internal security) had assured him that it had no objection to granting the passport. However, that power has passed into the hands of ASIS.

"What is the objection to being fair?" he said. "Our whole team was marooned in London for ten months while Senator Brandis threatened us with prosecution and seizure of our passports that stopped us from pursuing the case at the Hague."

Shirley Shackleton was there to remind us of the depth and length of Australia's betrayal of Timor Leste. Her husband was

one of the five Australian journalists savagely murdered by Indonesians invading East Timor in 1975 when both the Australian and Indonesian governments were denying that such an invasion was taking place. "East Timorese children were being taken away in cages, so that they grew up not even knowing that they were Timorese."

And of course "...it was always about the oil." In 1989, Labour Foreign Minister Gareth Evans and Indonesia's Ali Alatas negotiated and signed a joint development treaty over the 'Timor Gap' estimated to have over \$40 billion worth of oil and gas resources. Gareth Evans and Ali Alatas were famously photographed toasting with champagne in a chartered jet as it flew over the disputed region.

Colleary reminded us that the whole operation two years ago against his office and the witness was a "rearguard action" to cover up an illegal operation that is liable to prosecution. "The perpetrators have been 'moved on'; Downer has been assigned to an overseas posting..."

Senators Nick Xenophon, the Greens' Scott Ludlam, and Labor's Shirley Moore were there to speak and support Bernard Colleary's call for a further enquiry into the Defence and Foreign Affairs Committee, which would also enable 'witness K' and others to give evidence about the misuse of ASIS to ensure "...that we can never ever have the term National Security used to hide corporate greed."

Illegal logging threatens Purple Spotted Gudgeon habitat

The North East Forest Alliance has once again asked the Minister for Fisheries to intervene to make the Forestry Corporation comply with its Fisheries Licence and immediately stop illegal logging of headwater stream buffers in habitat of the endangered Purple Spotted Gudgeon.

The Forestry Corporation's June logging lists state that they are currently logging buffers on headwater streams in 20 compartments that qualify as habitat of this endangered fish.

"We recognise that the Forestry Corporation have been forced to stop logging of stream buffers in 37 of the compartments that we identified two months ago, but they are continuing to log stream buffers in five compartments in Styx River State Forest, and have commenced logging of stream buffers in 15 additional compartments in Bril Bril, Broken Bago, Burrawan, Landsdowne, Riamukka and Chichester State Forests that constitute Purple Spotted Gudgeon habitat that weren't on their March logging lists," NEFA spokesperson Dailan Pugh said.

"It is absurd that when we identify one area where they are illegally logging, that they stop there and start doing it somewhere else.

"We have repeated our request to the



Fisheries Minister, Niall Blair, to not only stop this new illegal logging, but to give a clear directive that all illegal logging of stream buffers in habitat of Purple Spotted Gudgeon must stop.

"We have now obtained a variety of documents under a freedom of information request that show that the Forestry Corporation were informed by Fisheries of the presence of Purple Spotted Gudgeon habitat in Gibberagee SF when preparing their logging plan but chose to ignore it when allowing the logging of stream buffers.

"This is a clear and intentional breach of their legal obligations for which they must be held to account.

"We have recently provided

evidence to Fisheries of widespread illegal logging of stream buffers in Conglomerate State Forest, and they have assured us they are doing their own audits elsewhere.

"For too long Fisheries have ignored the activity of their Forestry colleagues in the Department of Industry. This time they must fulfil their responsibilities as a regulator by prosecuting the Forestry Corporation for their intentional illegal logging.

"The Forestry Corporation must be required to undertake environmental repair and provide compensatory habitat for the hundreds of kilometres of stream buffers that they have illegally logged in the past year," Mr. Pugh said.

It's *medical* cannabis not *political* cannabis

The seed of medical cannabis activism in Australia is now sprouting within the “straight” world. Passionate and determined “elder” pot activists are being joined by equally outspoken doctors, nurses, patients, parents, military and law enforcement veterans, academics, journalists, lawyers, business people, bureaucrats, and politicians. The world of cannabis is becoming mainstream in Australia.

Two major pot events in Melbourne in late June represented these emerging voices. While the event programs focused on educating the medical profession around the medical uses of cannabis, they were important points of networking and forging collaborations among the various interests.

The third United in Compassion Medical Cannabis Symposium was preceded by a first for Australia – a one-day introductory cannabis course for doctors by doctors about using cannabis to treat a range of serious conditions ranging from pain management, relief from chemotherapy induced nausea, to childhood epilepsy.

Hosted by Dr David Caldicott, senior medical lecturer at the Australian National University, the program also covered navigating the current cumbersome legal framework for accessing medical cannabis in Australia. Federally, medical cannabis is legal, but its prescription is extremely limited to a small number of medical conditions as determined state by state.

Rather than decriminalisation or legalisation, Dr Caldicott prefers to talk of the “medicalisation” of cannabis. Dr Bastian Seidel, President of the Royal Australian College of GPs [RACGP], echoed in a panel discussion: “It’s become *political* cannabis, and it should be *medical* cannabis”. Dr Seidel’s view is that health care should be between the patient and doctor. The politician middle man is not required. Because the RACGP represents 35,000 GPs in Australia, his presence should be considered a highlight of the weekend.

The Symposium heard from a range of medical cannabis experts from the USA and Israel – specialists, GPs, researchers, and neuroscientists – who offered a varied and in-depth exploration of their utilisation of medical cannabis with patients, and cutting edge research results. Participating Australian speakers highlighted the utmost importance of education.

Representatives from the government’s Therapeutic Goods Administration [TGA] pulled out at the last minute, and left the hard work of fielding the overwhelming inquiries to the head of the Office of Drug Control, Bill Turner. Bill was generous and patient in his

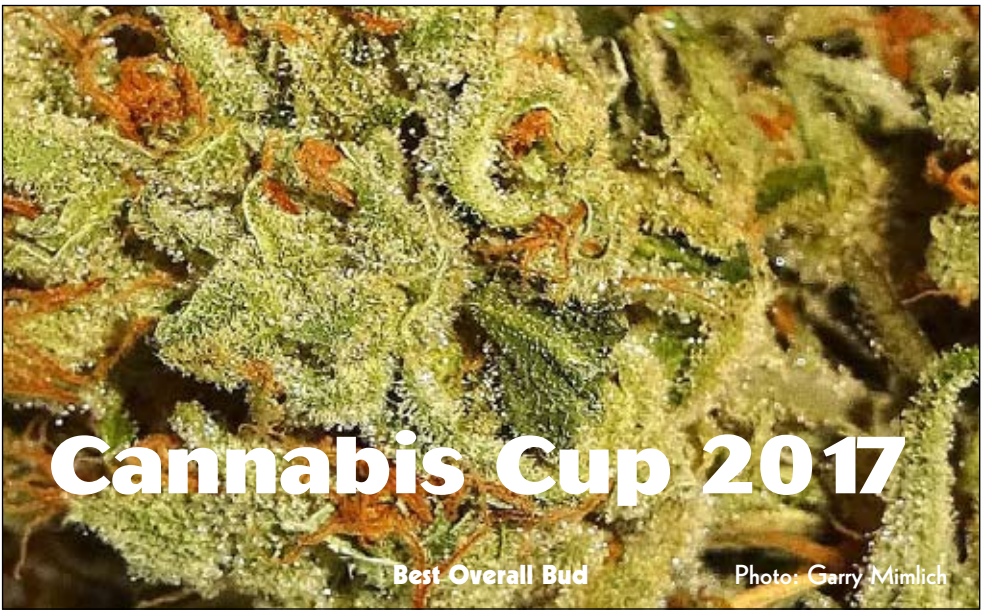
responses, and over the three days of the conference, we noticed that he morphed from a dark suit into sporting a gorgeous pink jacket on the last day. Marijuana works in mysterious ways!

The Nimbin Hemp Embassy’s message of Homegrown Health Insurance was thankfully echoed by some of the speakers who include personal control of our own health, and the ability to grow our own, as crucial aspects of any future regulations in Australia. Barrister Greg Barns stressed that personal pain management is a human right.

Richard Di Natale of The Greens called for government to focus on cultivating an Australian medical cannabis industry, rather than importing products from overseas. The Medical Cannabis Council, launched during the symposium, plans to provide a unified voice for the industry to negotiate with government. Other aims of the Council include supporting Australian-based medical cannabis research, and improving the accessibility of medical cannabis. Pot is getting very organised.

Even though underground medical cannabis has been dispensed for decades in Australia, new businesses in the production of medical cannabis are starting to jockey for position in the emerging regulated industry. It’s exciting that *hemployment* and a thriving Australian cannabis industry may be on the horizon, but sadly there is no discussion about how to make room for, or how to accommodate, the existing black market medicine makers.

Their products are working wonders for thousands of Australians, but there is a cone of silence around their use because of their current illegal status!

On a heavy track with wind and rain, the Nimbin Cannabis Cup was held over two days on an auspicious weekend in June.

For the first time, the organisers split the traditional one-day gala into a two-day extravaganza of Cannabis Cup on the Saturday, and Hashish Dish and Extracts Cup on Sunday, as described in the original Testament.

Held at a meticulously maintained abode with the most fantastic of hosts, as well as the exceptional organisational and cater-munchie skills of Ganja Faeries on display, the weekend proved another great success.

Judging panels had organised themselves well in advance, some specialising in buds alone, others only ever judging hash and extracts and several contemporary judges chose to help out on both days.

With 21 runners in the field on the first day, judges were more than impressed with the quality and quantity of buds at the starting gate.

Despite inclement weather wreaking havoc at a crucial time of the year for many growers, this only gave these top class growers the opportunity to show their experience and dedication to the craft by strutting their resin-laden fillies for all to see and judge.

Resin rich or solid dry-grain trichomes, self-emitting aroma or coaxing smells with a strategic pinch to release the terpenes and volatiles which give out their signature scents, these judges knew their stuff. Strain and pedigree recognition wasn’t hard to hide from the panel as they inspected every important detail worth looking at.

So as the field headed to the straight and the smoking began, judges saddled in for an afternoon of putting each bud through all its paces, and at the end of the first day there emerged a clear winner through the mud and rain.

Upon plate number 10, the exquisitely 5 star indoor grown offering by the most elegant Lady Haze, the winner of the 2017 Nimbin

Only 13 behind, and managing to scoot around the rest of field of indoor equally impressive outdoor runners, second place, bred, raised and trained by the original stalwart of Cannabis Cupping, went to a man who likes to be known as Henry, mostly because that’s his name. Henry’s outdoor-grown beauty, going by the name of Jean Guy from plate number 4 was always going to be amongst the leaders.

Hashish and extracts

The inaugural staging of the Hashish Dish and Extract Cup as a single-day event went off with most Australians not even noticing.

In many countries, it’s only about the hash and technical extracts. From the earliest of times, the silk routes provided the essential fabric to perfectly allow the passage of resin glands through its delicately and precisely woven micro-mesh when dry buds are gently rubbed over it.

The dry fluffy powder which makes it through is collected and pressed to form the ‘black putty’ transported all over the world for centuries and used as essential medicine and for a good time. That’s what humans do.

We introduced the old

to the new by combining both Cups on a single day of slow motion, slow thinking judging. Everyone was immensely pleased with the 16 entrants, which ranged from partial compressed pollen, water hash and butane extractions.

Judging lasted several hours, most swapping from hash tasting back to the Pure Haze ‘Dab Bar’ where various devices were arranged for the consumption of the highly refined extracts. Several judges used the Dab Bar to clear their palette before moseying back for another dank hash smoke. A subdued but delightful day was had by all.

The business end of the day turned out much like the bud-fest the day before. For the Extract Cup, in first place, on plate number 1, with 54 points, from The Alchemist known as Arthur Dent, a butane-extracted beauty, from outdoor grown cannabis, Housewives’ Poison.

For the Hashish Dish, in first place, on plate number 10, with 46 points, by the half-baked hands of the Gingerbread Man, the new star on the block and winner from last year, from his own outdoor crop, was Love Potion Hash.

Thanks again to all who made the weekend another magical event.

Saturday 17th June. I attended a women-led Ban the Bomb march to the UN Dag Hammarskjöld Plaza, for a rally. It was stated that a global ban on the world's most destructive and inhumane weapons could be adopted at the UN within a matter of months in spite of a

boycott by nuclear weapon states and several of their allies, including Australia. Elayne Whyte Gómez, the Costa Rican ambassador presiding over the historic UN disarmament negotiations that began in New York last week, believes concluding a nuclear-weapons-ban treaty by July 7 is "an achievable goal." Adopting the treaty does not hinge on the approval of the nine nuclear-armed nations. While they may refuse to participate in the process, they cannot veto it. See: ICAN-Australia-2015.pdf

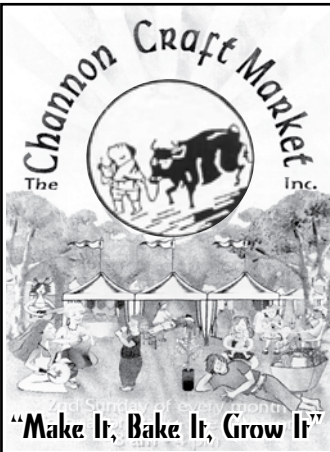
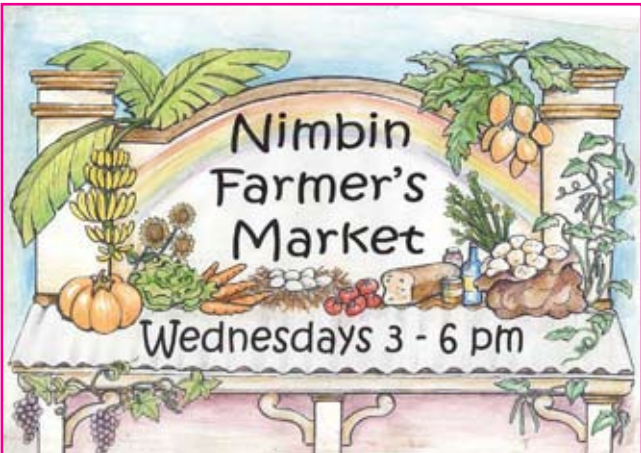

Right at the beginning of the month, on Friday 2nd June, NEC and other local activists joined an Australia-wide Greenpeace-initiated action to draw attention to and protest the Commonwealth Bank's continuing support of the fossil fuel industry.

To date, Commbank has lent billions of dollars to fossil fuel industries and has not ruled out funding the Adani Carmichael coal mine.

We picketed the pop-up Combank in Lismore with banners, placards, tee-shirts and sang songs to raise awareness in bank customers and passers-by.

Following this, the protest marched to Kevin Hogan's office with a letter of demands, that he represent his electorate's opposition to supporting the fossil fuel



industry.

NEC participated in World Environment Day on Sunday 4th June in Murwillumbah with a stall shared with Northern Rivers Guardians, distributing information and selling our NEC shop's beautiful local and ethically-sourced goods.

The informative and deeply moving movie *Blackfish* was shown at Birth and Beyond on Thursday 1st June, with

a speaker from Australia for Dolphins giving a very revealing talk on the captive marine mammal trade. The film reiterated the shocking plight of orcas in captivity in marine parks and gave hope that with awareness and protest, this practice will end.

NEC is hoping that Lismore Council's great initiative of 'No plastic bag July' can be continued permanently and is working

on encouraging this practice in Nimbin. Watch this space!

Using technology to educate about medicine

In the past 20 years, technology has developed very quickly in Australia and many people now use their computers and smart phones to find information, manage arrangements and appointments.

The health industry has realised the importance of using technology for people to educate themselves about their medical condition and medicines that have been prescribed. A number of informative websites have been developed for the general public.

One of them is NPS MedicineWise (nps.org.au), an independent, not-for-profit and evidence-based organisation that was set up in 1998 with the aim of "promoting quality use of medicines" and then expanded to connect with health consumers and health professionals in Australia to assist them to make the best possible healthcare decisions.

You can read more about what this organisation offers on their website: www.nps.org.au.

Anyone with a computer can access the site and look up information on medications or read articles about statins, antibiotic resistance, acute ankle or knee injuries or coughs, cold, earaches in children. The articles are

changed regularly and each has a heading showing the time it takes to read it.

Recently NPS produced an app (program) called MedicineWise. You can download it for free onto your smart phone or computer from Google Play or the App Store. It is designed for people to keep track of their medicines easily and access important health information any time and anywhere, especially in emergencies. It can also be used by carers.

On the website it says that, with this application, you can:

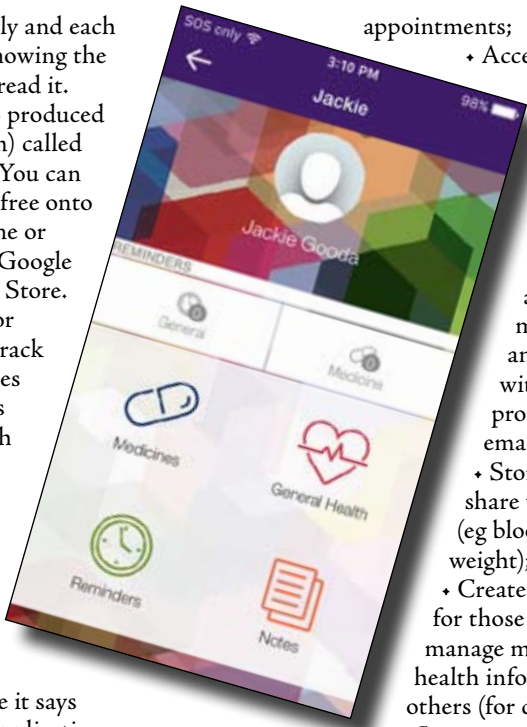
- Create a list of medicines by scanning your medicine bar codes or searching the MedicineWise database of Australian medicines;
- Record important health information such as medical conditions, allergies and health professional contact details (doctors, specialists, allied health practitioners);
- Set reminders for when to take medicines and attend doctor's

appointments;

- Access Consumer Medicines Information (CMI) to learn more about your medicines;
- Generate and share your medicine lists and usage reports with healthcare professionals via email;
- Store, graph and share your test results (eg blood pressure, weight);
- Create separate profiles for those in your care to manage medicines and health information for others (for carers); and
- Store notes and questions to ask your doctor.

So you have the opportunity now to be part of the digital age with your medical information stored on your device and enjoy keeping your own records and learning more about medicine, health and wellness.

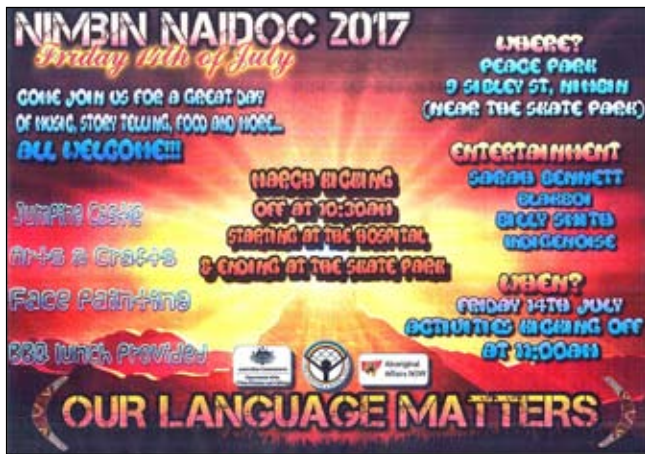

The kill rates of wildlife on the roads in and around Nimbin are an ongoing disgrace. Stony Chute Road is perhaps the worst, though there are many other contenders.

Stop funding Adani

An open letter to Page MP Kevin Hogan

Dear Mr Hogan,

You may recall that in February of this year, a letter, signed by 20 plus of your constituents, was delivered to your office. To the best of our knowledge, no confirmation of receipt, acknowledgement of our concerns, or answers to our questions, were ever forthcoming.

Let me refresh your memory. We were deeply concerned about the proposal that taxpayers' funds be used to provide infrastructure for the disastrous Adani coal mine in the Galilee Basin. This proposal is still on the federal government's agenda.

We trust that the lack of response on your part does not indicate a lack of willingness to do all in your power to ensure that not a dollar of taxpayers' money is used to provide infrastructure to advance this horrendous project.

Since February, 2017, the feared trajectory has unfolded.

Following Cyclone Debbie, Adani requested that pollution controls at their Abbott Point facility, be eased. The Queensland government acceded to that request by granting a temporary emission licence to release water containing up to 100mg of sediment, ie coal dust, per litre.

On day four of the four day licence, Adani, by its own figures, exceeded that concession by releasing water with 806mg of sediment per litre, into fragile Caley Valley wetland. That's an excess of 800%. We repeat, 800%.

The Attorney General attempted to weaken the *Native Title Act*, then intervened on behalf of Adani, in the court case brought by the Wangan and Jagalingou Traditional Owners Council.

The recently released Oxfam report: 'More Coal Equals More Poverty: Transforming our World Through Renewable Energy', debunks coal industry spin that coal alleviates poverty. 'Climate change, fuelled by dirty coal pollution, could drive a staggering 122 million more people into extreme poverty by 2030. There is no space for new coal.' Another major finding in this report, is that coal, of itself and as a fuel for power generation, is a public health disaster. This confirms that Old King Coal IS a dirty old soul.

In the past week the Climate Council

has released a report titled: *Risky Business: Health, Climate and Economic Risks of the Carmichael Coalmine*. Key findings in that report are:

1. Developing any new thermal coal mines, particularly of the scale of the Carmichael mine in the Galilee Basin, is fundamentally at odds with protecting Australians from the impact of climate change;
2. Opening up the Galilee Basin undermines other industries, such as tourism and agriculture;
3. Coal is very harmful to human health; and
4. The Carmichael mine is a risky financial investment and promises of economic benefit are overblown.

We know that you have access to that report, as at least one of the undersigned sent you the link.

Ian Dunlop, former senior coal industry executive, writing in the *Sydney Morning Herald*, described the Adani mine as constituting an 'existential threat of climate change'. He defined existential as: 'a risk posing large negative consequences to humanity that can never be undone. Where an adverse outcome would either annihilate life, or permanently and drastically curtail its potential.'

Yet, the federal government is still proposing to use taxpayers' funds to assist with the death of our iconic Great Barrier Reef, and the elevation of temperatures sufficient to bring devastation to planet earth.

We reiterate our question: Who do you represent Mr Hogan? If you reply that it's your constituents, what are you actually doing, and/or are you prepared to do, to bring our demands and protests to the attention of the highest levels of government?

We restate our demands: We're living with climate change, Mr Hogan, and need effective, honest representation. We expect you to strongly oppose your government's trivialisation of climate change. We insist your government stops pandering to Adani, a totally unscrupulous mining corporation. We demand not one cent of our taxes funds any coal mining of the Galilee Basin.

The Ciska Cassa collection

There will be an exhibition and sale of the Ciska Cassa collection in Nimbin Town Hall on Sunday 9th July, 11am – 4pm.

Shortly before Ciska died in May, she invited me into her house, and asked me if I would move into the back bedroom in order to keep her company, help sort through all her stuff and dispose of it so that she could leave the house with no possessions. Every room was filled with Ciska's collections. I agreed to do this, we went into the back to begin clearing and sorting to make room for me to move in.

She talked about selling her best pieces on eBay to raise money for Rainforest Rescue. Two days later, I heard that she had taken her own life. After her funeral and wake, once her family and friends had taken what they wanted from her house, it was clear that everything remaining would be dumped

unless I stepped in – so I did.

The landlord has graciously postponed needed renovations to allow me time to sort slowly, carefully, respectfully and re-distribute items. As I moved through the rooms many things became clear.

Ciska was a very intelligent, passionate, creative and beautiful woman. She collected beauty, she created beauty, she appreciated beauty... both man-made and natural. She cared deeply about her environment... she recycled everything, she re-purposed many things, she re-used, she mended, she re-created.

Going through her papers, she had given many times to Rainforest Rescue, the Wilderness Society and other charities. She had volunteered in the Environment Centre and participated in protests and actions.

She was very creative, making clothes, lace, hats, jewellery, baskets, braiding,

painting, drawing, crochet, knitting, collage – and in terms of personal style she made herself into a work of art, brand new every day...

Much of her beautiful collection had to be thrown out, but there still remain enough beautiful things to follow her last wishes and sell them to raise money for Rainforest Rescue.

This is emphatically NOT a garage sale. The world has enough junk in it. The ordinary household goods are going to Lifeline/Vinnies/Salvation Army as appropriate.

What will be shown and sold on Sunday 9th July will be only her most beautiful things: clothes of great taste and unique style; marvellous hats; extraordinary fabrics, from scraps through to larger pieces; belly dancing gear; wall hangings; baskets and bags of all shapes and sizes; bamboo, cane, wicker, wood, iron and glass furniture; artworks; curious objects; craft books, tools

and materials; and more... Take home some unique beauty to keep.

The curated Ciska Cassa Collection has to be seen to be believed. Even those who did not know her will appreciate her gift for beauty.

The funds raised will go to Rainforest Rescue. Half to the organisation of that name, and half to the Nimbin Environment Centre to support local actions that defend, extend and repair the rainforest.

The inconvenient truth about flying

Many would probably prefer not to know the implications of flying, but it certainly needs to be told and it's having a grave effect on our planet.

Now more than ever before Australians are flying. In 2011 Australia hit a record high of 7,795,000 passengers travelling overseas and this doesn't include domestic flights. This is an astonishing increase of 371% compared to 1991 with only 2,099,300. Of those passengers, 79% of their destinations were solely for a vacation or visiting friends and family. Approximately 93,000 scheduled international flights leave airports every day around the world as well as 50,000,000 tonnes of cargo being transported every year.

From 1990 to 2006 emissions from the aviation industry increased by a shocking figure of 87% in the European Union and yet the aviation sector still literally flies under the radar when it comes to restrictions on emissions.

Flying has a dramatic effect on climate change as well as global dimming. Aircraft when in flight emit many toxic substances, not just CO² but water vapour, hydrocarbons, carbon monoxide, nitrous oxide, sulphur oxide and black carbon.

When you discover that a Boeing 747 in flight is using four litres of fuel per second, which translates to 150,000 litres of fuel for a 10-hour flight, it's not surprising that emissions are at such a high level. This is equivalent to driving a car for one year for each passenger on board. But if we look at statistics over the last five years then planes currently account for more global warming than all the cars on the entire planet! A return trip from New York to Europe creates a warming effect equal to two to three tons of carbon dioxide per person.

Planes cause more warming to our planet when the impact occurs at high altitudes, creating vapour trails and ozone production. This process causes as much warming as the CO² itself. The science is still coming in, but scientists

from the Intergovernmental Panel on Climate Change believe that contrails have an input on climate forcing. They call it the Aviation Multiplier and it claims that to get the true amount of emissions when flying, you must multiply the planes carbon emissions by two.

NASA has also done research into the atmospheric and climatological effects of contrails, including impacts on ozone, ice crystal formation and particle composition. The Atmospheric Effects of Aviation Project concluded that there is definitely a warming effect, however the effect varies daily and annually. The evidence also revealed how contrails at night have a tendency to stop heat escaping from the earth and this effect was studied by scientists when a rare opportunity occurred with the grounding of aircraft on 9th to 11th September 2001.

Unfortunately, the outlook for more environmentally friendly planes is very limited despite efficiency innovations, ranging from airframes to engines and aerodynamics as well as flight operations. It's still predicted that it will be many decades till we achieve major results and bio fuels have been looked at but this just isn't viable, when it's been concluded that it would require 1/5 of the world's crop lands to meet the demands. This figure would only grow over time. There have been many advances towards more environmentally friendly cars, but these innovations just cannot be applied to the aviation sector at present. The biggest hurdle is getting the planes off the ground, and electric engines just aren't capable of delivering enough power.

On 27th September 2016, the United Nations led talks with the International Civil Aviation Organisation in Montreal. The proposed landmark deal was aimed at curtailing progressively rising emissions from the International Aviation Industry. The goal is to limit emissions to 2020 levels after it takes effect in 2021 but with this treaty they have until 2027 to comply.

The aviation sector was excluded

from the December Paris talks, and this is another display of the power most multinational corporations have. Time is of the essence, yet international bodies and corporations continue to time and time again, procrastinate on this monumental problem with still no sincere policies that would make a real difference to climate change.

Air travel is not the only issue with this industry. It is the massive amounts of land that is required to support the airports and in addition the energy these facilities need to operate. They more often than not are situated in prime locations in cities across the globe and are constantly expanding due to the growing demand for air travel. The largest airport in the world is Atlanta City which covers a staggering 1,480 hectares and that's equal to 1,850 soccer fields.

Mascot Airport is a perfect example of the current problems that the aviation industry is facing. Landowners are now being forced off their properties at Badgery's Creek because Mascot Airport is inadequate and cannot meet the growing needs of this booming industry. Coolangatta Airport has plans to expand and the wetlands will be lost. Will we continue to destroy land recklessly for an industry that has no bounds? It seems unavoidable, when there are future plans for Tyagarah Airport, Ballina and many other airports in regional localities.

No wonder the industry is growing when we have such affordable airfares, and this explains why aviation fuel takes up to 10% to 15% of an oil refinery's production. Roughly 3,000 tonnes of fuel is processed daily just for aircraft. Worldwide there are no international taxes on aviation fuel, yet this industry is one of the largest contributors to global emissions. Without market constraints, this growth in greenhouse gases will eventually result in nearly all annual global emissions coming from the aviation sector by 2050.

Many unique parts of the world are being destroyed now because of the explosion of tourism in recent years and where will it end?

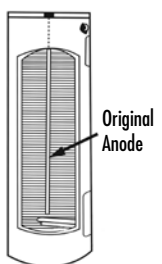
